- Install, move, and modify Surveillance, Security, Audio systems and related equipment according to job order specifications, standards, and procedures.
- Install conduit.
- Install/pull cable and wire.
- Mounting panels, field devices, computers, power supplies.
- Programming, set-up, testing systems.
- Diagnose equipment malfunctions.
- Maintain and submit accurate paperwork and documentation.
- Report and monitor service order changes.
- Maintain and repair systems and equipment according to manufacturer recommendations and specifications.
- Respond to on-call assignments after business hours.
- Perform additional functions incidental to technicians.
- Ensure that all statutory requirements (e.g. Local Code Enforcement, EPA etc.) are adhered to on site at all times.
- Develop a full understanding and working knowledge of the Company's OH&S Policies and Procedures and OSHA regulations, ensuring all site personnel adhere to them at all times.
